


## **RESIDENCE PERMIT**

## FOR EXCEPTIONAL REASONS 3 YEARS

## **DOCUMENTS (8)**

- 1. 4 PASSPORT PHOTOS (4x6) AND ON CD
- 2. **PHOTOCOPY OF ALL PAGES OF ALL PASSPORTS** (WHICH COVER THE 7 YEARS BEFORE THE DATE OF APPLICATION)
- 3. FEE (PARAVOLO) FOR THE 3 YEARS 300€
- 4. **FEE (PARAVOLO) FOR THE CARD 16€**THE CODES FOR THE FEES CAN BE PRINTED FROM <u>www.gsis.gr</u> **OR**FROM KEP AND THEN THE PAYMENT IS DONE AT THE BANK
- 5. (IF CITY OF BIRTH IS NOT WRITTEN ON PASSPORT) OFFICIAL AND STAMPED DOCUMENT FROM YOUR EMBASSY WHICH STATES YOUR PLACE OF BIRTH IN ENGLISH, TRANSLATED AND CERTIFIED BY THE MINISTRY OF FOREIGN AFFAIRS
- 6. APPLICATION OF RESIGNATION (IF YOU HAVE AN OPEN APPLICATION AT THE MINISTRY OF INTERIOR)

  \*THOSE WITH A PENDING ASYLUM APPLICATION (PINK CARD)
  WILL NEED TO GIVE UP THEIR APPLICATION
- 7. HOUSE CONTRACT PRINTED FROM TAXISNET
  \*IF YOU ARE BEING HOSTED, A DECLARATION FROM THE
  LANDLORD AND TENANT IS REQUIRED
- 8. DOCUMENTS WHICH PROVE 7 YEARS OF CONTINUOUS RESIDENCE IN GREECE AND NO ABSENCE FOR MORE THAN 6 MONTHS (SEE VALID EXAMPLES ON THE NEXT PAGE)





## **EXAMPLE DOCUMENTS**

- PROOF OF ATTENDANCE OF GREEK PUBLIC SCHOOL (OF THE APPLICANT OR THEIR CHILDREN)
- APPLICATION FOR ANY TYPE OF RESIDENCE PERMIT OR INTERNATIONAL PROTECTION (ASYLUM APPLICATION)
- WORK PERMITS OR PROOF OF APPLICATION FOR WORK PERMIT
- COPIES OF REJECTION LETTERS OF APPLICATIONS FOR OR RENEWAL OF RESIDENCE PERMITS
- PREVIOUS RESIDENCE PERMITS (REGARDLESS OF THE ISSUING AUTHORITY)
- COPIES OF PREVIOUS TAX DECLARATIONS
- COPY OF TAX NUMBER (AFIMI) DOCUMENT
- PROOF OF PUBLIC SOCIAL SECURITY INSURANCE
- HEALTH BOOKLETS
- UTILITY BILLS (ELECTRICITY, PHONE, WATER) AND MOBILE PHONE BILLS IN THE NAME OF THE APPLICANT
- BANK BILLS
- RECEIPTS OF INTERNATIONAL MONEY TRANSFERS TO THE APPLICANTS COUNTRY OF ORIGIN
- CERTIFICATION OF ATTENDANCE OF GREEK LANGUAGE COURSES
- JUDICIAL (COURT) DECISIONS
- DEPORTATION DECISIONS
- DECLARATIONS FROM THE CIVIL REGISTRY OFFICE
- DOCUMENTS WHICH PROVE HOSPITALIZATION
- CONTRACTUAL DOCUMENTS DRAWN UP IN THE PRESENCE OF THE APPLICANT
- EXCERPTS FROM ANY OFFENCES BOOKS KEPT BY A POLICE STATION
- SERVICE NOTICES REQUESTING DEPARTURE FROM THE COUNTRY
- CERTIFICATES OF THE ISSUING OF URBAN TRANSPORTATION CARDS
- ANY OTHER DOCUMENTS ISSUED BY PUBLIC AUTHORITIES
- PRIVATE DOCUMENTS (EXCEPT SOLEMN DECLARATIONS) WHICH ARE VALIDATED IN TERMS OF THE ISSUING DATE BY A SOLICITOR OR OTHER PUBLIC OFFICIAL

\*ATTENTION: YOU ARE NOT PERMITTED TO BE ABSENT FROM THE COUNTRY FOR MORE THAN 6 MONTHS
