- 6. RECENT COPY OF MARRIAGE/CIVIL UNION CERTIFICATE
 CERTIFIED AND TRANSLATED BY THE MINISTRY OF FOREIGN
 AFFAIRS
- 7. FAMILY STATUS CERTIFICATE (IN CASE THE CIVIL UNION TOOK PLACE IN GREECE)
- 8. VERIFIED PHOTOCOPY OF **REGISTRATION CERTIFICATE OF EU**CITIZEN OR COPY OF PERMANENT RESIDENCE PERMIT OF EU
 CITIZEN
- 9. HOUSE CONTRACT PRINTED FROM TAXISNET

- 3. COPY OF LAST RESIDENCE PERMIT
- 4. FEE (PARAVOLO) FOR THE CARD 16€
