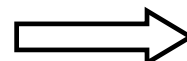

4. **COPY OF DOCUMENT SHOWING LEGAL RESIDENCE IN GREECE (VISA  
TYPE C, CERTIFICATE TYPE A, RESIDENCE PERMIT, SPECIAL CERTIFICATE,  
EXPATRIATE ID OR REFUGEE CARD OR ASYLUM APPLICANT CARD IF THE  
PARENT HAS BEEN LIVING IN GREECE FOR AT LEAST A YEAR OR  
RESIDENCE PERMIT FROM ANOTHER EU COUNTRY IF THE HOLDER  
ENTERED GREECE THE PREVIOUS 3 MONTHS)**

9. **PROOF OF THE PARENT'S FINANCIAL DEPENDENCE ON THE GREEK  
CITIZEN OR THEIR SPOUSE (BANK TRANSFERS OR TAX DECLARATION  
SHOWING ZERO INCOME)**
10. **SOLEMN DECLARATION BY THE GREEK CITIZEN OR THEIR SPOUSE  
THAT THEY WILL COVER THE PARENT'S EXPENSES**
11. **HOUSE CONTRACT PRINTED FROM TAXISNET BUT IF YOU ARE BEING  
HOSTED, A DECLARATION FROM THE LANDLORD AND TENANT IS  
REQUIRED**
