  OF HEALTH BOOK WITH AMA, AMKA & AFM OF FAMILY
  MEMBER SPONSORING YOU
- 6. **RECENT FAMILY STATUS CERTIFICATE** ISSUED BY OFFICIAL AUTHORITIES OF THE COUNTRY OF ORIGIN, STAMPED AND TRANSLATED BY THE GREEK MINISTRY OF FOREIGN AFFAIRS
- 7. **DECLARATION OF THE SPOUSE** THAT THE MARRIAGE IS STILL VALID
