## NATURALIZATION **FOR FAMILY MEMBERS OF GREEK OR EU CITIZENS OR PARENTS OF UNDERAGE GREEK CITIZENS**

### **DOCUMENTS (10)**

1. **A PHOTOCOPY OF THE CITIZENSHIP DECLARATION.** THE DECLARATION IS SUBMITTED AT THE MUNICIPALITY WHERE YOU RESIDE. YOU MUST HAVE **2 GREEK CITIZENS AS WITNESSES** AND THE DECLARATION MUST BE SIGNED IN FRONT OF THE MAYOR OR ANOTHER APPOINTED OFFICER
2. THE CITIZENSHIP **APPLICATION** ADDRESSED TO THE MINISTRY OF INTERIOR. THIS IS SUBMITTED TO THE DECENTRALIZED SERVICES. THE APPLICATION MUST BE COMPLETED IN GREEK AND SIGNED.
3. **A COLOR PHOTO**
4. **PHOTOCOPY OF PASSPORT**
5. **PHOTOCOPY OF RESIDENCE PERMIT** OF FAMILY MEMBER OF A GREEK CITIZEN OR EU CITIZEN OR PARENT OF AN UNDERAGE GREEK CITIZEN
6. **BIRTH CERTIFICATE OFFICIALLY TRANSLATED AND CERTIFIED** BY A GREEK CONSULATE\*. IF YOU HAVE A GREEK BIRTH REGISTRATION CERTIFICATE THIS IS ENOUGH
7. **PHOTOCOPY OF YOUR LAST TAX DECLARATION**
8. **SOCIAL SECURITY NUMBER (AMKA)**
9. A) IF YOU ARE A SPOUSE OF A GREEK CITIZEN WITH A CHILD: YOU NEED **FAMILY STATUS CERTIFICATE** FROM YOUR MUNICIPALITY  
  
B) IF YOU ARE A PARENT OF AN UNDERAGE GREEK NATIONAL: YOU NEED A **CERTIFICATE OF REGISTRATION** OF THE CHILD AT THE MUNICIPALITY
10. **FEE (PARAVOLO) - 100€**  
THE CODE FOR THE FEE CAN BE PRINTED FROM [www.gsis.gr](http://www.gsis.gr) OR FROM KEP AND THEN THE PAYMENT IS DONE AT THE BANK

\* The certificates should be officially translated from the Translation Service of the ministry of Foreign Affairs **or** the Consular Service of the country of origin **or** from a Greek lawyer **or** from a translator who has graduated the Ionian University School of Translation and **not from private offices.**
