COPY OF DOCUMENT SHOWING LEGAL RESIDENCE IN GREECE (VISA TYPE C, CERTIFICATE TYPE A, RESIDENCE PERMIT, SPECIAL CERTIFICATE, SPECIAL IDENTITY CARD FOR EXPATRIATES OR REFUGEE CARD OR ASYLUM SEEKER CARD THAT RESIDED IN GREECE AT LEAST ONE YEAR BEFORE THE MARRIAGE, RESIDENCE PERMIT FROM ANOTHER EU COUNTRY IF CAME TO GREECE IN THE PREVIOUS 3 MONTHS)**
- 5. PRINTING OF INSURANCE CAPACITY (DIRECT OR INDIRECT) OF A PUBLIC INSURANCE BODY (EFKA with submission of A.M.A. - A.M.K.A.- A.Φ.Μ.) or INSURANCE CONTRACT OF PRIVATE INSURANCE AGENCY**
- 6. PHOTOCOPY OF GREEK CITIZEN'S GREEK ID**
- 7. BIRTH CERTIFICATE OR OTHER OFFICIAL DOCUMENT OF DOMESTIC OR FOREIGN AUTHORITY, OFFICIALLY TRANSLATED AND CERTIFIED WHICH PROVES THE KINSHIP WITH THE GREEK CITIZEN OR THE OTHER SPOUSE**

9. **PROOF OF BEING FINANCIALLY DEPENDENT ON THE GREEK CITIZEN** (BANK TRANSFERS OR TAX DECLARATION SHOWING ZERO INCOME)
10. A SOLEMN DECLARATION OF THE GREEK CITIZEN THAT UNDERTAKES TO PAY ALL THE COSTS OF THE PARENT
11. **HOUSE CONTRACT** PRINTED FROM TAXISNET

- 6. CERTIFICATE OF FAMILY STATUS OR A COPY OF THE DIVORCE APPLICATION OF WHICH THAT THE MARRIAGE LASTS AT LEAST 3 YEARS AND ONE OF WHICH IN GREECE**
