4. **FEE (PARAVOLO) FOR THE CARD - 16€ (FEE CODE 2119)**

5. **PHOTOCOPY OF CERTIFICATE OF EU CITIZEN REGISTRATION**
6. **PRINTING OF INSURANCE CAPACITY (DIRECT or INDIRECT) OF A PUBLIC INSURANCE BODY (EFKA with submission of A.M.A. - A.M.K.A.- A.Φ.Μ.) or INSURANCE CONTRACT OF PRIVATE INSURANCE AGENCY**
7. **COPY OF MARRIAGE CERTIFICATE OF PARENT (IF NEEDED)**
8. **BIRTH CERTIFICATE OR FAMILY STATUS CERTIFICATE WHICH SHOWS FAMILY RELATIONSHIP VALIDATED AND TRANSLATED**
9. **SOLEMN DECLARATION FROM THE EU CITIZEN THAT THEY ARE RESPONSIBLE FOR ALL MAINTENANCE AND LIVING COSTS**
10. **HOUSE CONTRACT PRINTED FROM TAXISNET**
*IF YOU ARE BEING HOSTED, A DECLARATION FROM THE LANDLORD AND TENANT IS REQUIRED

- 11. FOR UNDERAGE CHILDREN NOT DIRECTLY DESCENDANT: OFFICIAL DOCUMENT FROM FOREIGN CONSULAR WHICH SHOWS THAT THE CHILD IS PERMITTED TO LIVE IN GREECE (COURT DECISION OR CUSTODY AGREEMENT OR WRITTEN AGREEMENT BETWEEN PARENTS ALLOWING THE CHILD TO LIVE IN GREECE)**
- 12. OFFICIAL DOCUMENT THAT STATES YOUR PLACE OF BIRTH IN ENGLISH (FOR EXAMPLE BIRTH CERTIFICATE, PASSPORT ETC.)**

COHABIT AND HE/SHE IS RESPONSIBLE FOR ALL MAINTENANCE
AND LIVING COSTS**
- 7. AN EXACT COPY OF THE PERMANENT RESIDENCE CARD OF
THE EU CITIZEN**
- 8. OFFICIAL DOCUMENT THAT STATES YOUR PLACE OF BIRTH IN
ENGLISH (FOR EXAMPLE BIRTH CERTIFICATE, PASSPORT ETC.)**
