1. Network meetings

1.1 Network meetings in Spain

On 18th/11/2020 the "III Networking Meeting" with public and private entities was held in Spain. The objective was to know and recognize the inter-institutional network with migrants and the responses in cases of sexual and gender violence. In addition, the meeting allowed finalizing the document that collects the itineraries to respond the needs of the SGBV among the migrant community, as well as good practices and challenges. Social agents and stakeholders from 15 welfare institutions, 8 of which were public and 7 were ONGs.



Furthermore, during this last meeting, networking was fundamental to the further development of the protocol. In this way, the institutions made relevant contributions to make the document as complete as possible, these contributions refer to: contact telephone numbers, areas of intervention, among other contributions. Finally, the minutes of the meeting were taken.



The result of the three network meetings with public and private entities has given rise to a "Guide for intervention in cases of sexual and gender-based violence among migrants: routes, challenges and good practices" which will be disseminated by the different entities so that they have an accessible resource to improve networking among the entities to maximize the use of the resources available to the different institutions.



1.2 Network meetings in Greece

KMOP and Generation 2.0 organized 3 network meetings with the participation of professionals belonging to Institutional and Private entities working on health, legal and social services that deal with SGBV and migration.

1. Network meetings

Due to legal restriction of gatherings to avoid the spread of the COVID-19 pandemic, all the network meetings were held online using the platform "Zoom".

The network meeting of the health care sector took place on 18th/9/2020, with the participation of 12 professionals belonging to various authorities and organizations.



Both network meetings regarding the sectors of social care services and legal services took place on $9^{\text{th}}/10/2020$.

In the social care network meeting 8 professionals participated belonging to various authorities and organizations such as the Migrant Integration Center of the Municipality of Athens, Irida, Metadrasi, Melissa, Human Rights 360, Greek Forum of Refugees, Action Aid Hellas and others. In the legal services network meeting 9 professionals participated various authorities belonging to and organizations such as the Office of the National Rapporteur on Trafficking in Human Beings (Heracles Moskoff), the General Secretariat of Family Policy and Gender Equality, the National Center for Social Solidarity, the Greek Ombudsman, the Municipal Councilor for Refugees and Migrants of the Municipality of Athens as well as legal counselors and lawyers.



The feedback of the participants of the network meetings was included in the Mutual Protocol of Cooperation, enhancing it with significant practices to better respond to SGBV cases.

In addition, 7 entities (including 2 authorities and 5 NGOs) that participated in the network meetings agreed to sign the Mutual Protocol of Cooperation.



1.3. Network meetings in Italy

After the conclusion of the training for cultural mediators, the Italian team held two network meetings. The objectives of these meetings were to share the results of the work done with the cultural mediators, with the consequent promotion of the roster of trained professionals, and the promotion of the protocol aimed at enhancing the figure of the cultural mediator within the services. Online training was also promoted.

1. Network meetings

On 19th/11/2020 an ad hoc meeting was carried out with the person in charge of the Rose Code of the Tuscany region, Dr. Vittoria Doretti, in the presence of the director of the Global Health Center Maria Jose Caldes, the Head of the Anti-Violence Center La Nara, managed by the Cooperative Alice, Francesca Ranaldi, and Sara Albiani (CSG), Maria Nella Lippi and Cecilia Deserti (Oxfam).

This meeting was particularly important because the Rose Code network is made up of all the nodes that contribute to the provision of health care responses, in emergency and in the immediate aftercare, for different types of victims of violence, through specific paths dedicated to different targets.



The second meeting, held on December 21st, was attended by 25 people, representatives of health services, in particular women health clinic, the regional anti-trafficking network, members of the UNHCR, representatives of private social organizations including reception centers, anti-violence centers and also some mediators who participated in the training.



In this second meeting the results of the training were promoted by the trained mediators themselves, who shared how the training helped them to strengthen their professionalism.



Those responsible for mediation services suggested the opportunity for mediators to participate in professional development courses for the health staff with whom they work as a team.

The importance of being able to network effectively between the different services involved in the care of victims of violence and that all nodes of the network, including the mediators, are aware of each other's functioning was also highlighted.

From these meetings emerged the general appreciation of the work done by the project and the willingness to continue to collaborate.

2.1 Face-to-face course in Spain

The course in Spain "Prevention and response to sexual and gender violence in the context of migration" was attended by 37 participants from different public and private entities.

2.2 Face-to-face course in Greece

The training was organized in every day sessions during the week of $23^{rd}/11/2020 - 27^{th}/11/2020$ with a total duration of 25 hours.

The training had multidisciplinary approach, consisting of 50% lesson and 50% workshop. It included modules on health, legal and social aspects of SGBV. The methodology of the training was based upon the professional profile of the learners, considering the learners as constructors of their own knowledge.

The trainers were chosen based on their studies and work experience:

Module 1:

A) Presentation of Net – Care project.

B) Groups facilitation and Classroom pact.

C) Code of ethics for social workers dealing with SGBV victims, delivered by Natasha Alexopoulou (Lawyer specialized in Criminal Law).

D) Introduction to SGBV. Definitions and typologies, delivered by Maria Elli Doufexi Kaplani (Sociologist specialized in research on gender issues LGBTQI +, domestic violence, trafficking and human trafficking).
